This document serves as an agreement to all program policies and financial obligations for the 2022-2023 season. Please initial the statements below:

	I acknowledge that on the listed due dates my JackRabbit parent portal will be opened to make specified payment amounts. After 8:00 PM, accounts with outstanding balances will have card on file charged.
	I acknowledge that a \$25.00 fee will be incurred for payments returned for insufficient funds.
	I acknowledge that if my card cannot be successfully charged on specified due dates, a \$25.00 late fee will be added to my account. If my account is still not current after seven days, my account will be placed on hold and no SBD items will be distributed and my athlete may be sat out from practice and/or events.
	I acknowledge that I or my athlete decides to leave the program for any reason prior to April 30, 2023, or season completion – whichever is later, we are subject to a contract buyout of \$350. The contract buyout fee will be deducted from the card on file, and if the card is unavailable or invalid, the fee will be due by check or cash within three days of drop fee posting. All fees paid and items ordered will be forfeited once the drop fee is posted.
	I acknowledge that if my child has an unexcused absence, a \$25.00 missed practice fee will be charged to my account. If my child misses a practice within two weeks of an SBD event, a \$50.00 missed practice fee will be charged to my account and my child may be replaced in the routine.
	I acknowledge that if my child is late to an event call time or practice two weeks prior to a competition a \$50.00 late fee will be add to my account.
	I acknowledge that I am required to participate in one to two mandatory program fundraisers or opt-out and pay a flat fee. Required amounts are \$50 per athlete for novice and non-travel athletes and \$100 for travel athletes.
	I acknowledge that the cost of replacing any lost, damaged, or ill-fitting (too small or big) items will be the athlete/ family's responsibility. In addition, if my athlete arrives to practice without the correct attire and the SBD staff deems it necessary for them to match their team, the athlete will be given the necessary practice wear. The fee for the required item(s) will be automatically charged to my account.

	I acknowledge that in the event my athlete cannot compete, the competition fee will be applied to the fill-in athlete. If I would like my athlete to attend the competition, I will be required to purchase a spectator ticket for them OR pay the fee for them to be rostered as an alternate.
	I acknowledge that if my athlete is (1) placed on a TRAVEL team AND (2) selected to be a flyer and/or does not meet the level tumbling requirements, I am required to be on the DIVA+ monthly tuition option at a minimum.
	I acknowledge that I am responsible for updating my credit card information before the card expires, or I will be responsible for any fees that may result in an insufficient payment. If a fee was incurred, and the card was a victim of fraud or theft, you will need to provide a statement from your financial institution to have the fee removed.
	I acknowledge that I have fully read, understand and agree to the 2022-2023 SBD Program Information as well as the SBD Program Policies documents.

By initialing the statements above and signing below, I as the parent/guardian agree to be solely responsible for the 2022-2023 financial commitment for the SBD All Stars, LLC season. Please note, that items will not be distributed if any SBD All Stars, LLC balance is past due or the athlete/family decides to leave the program. All payments are non-refundable and non-transferable. Payments are never prorated/ refunded, in the cases of, but not limited to: illness/injury, sitting out, joining late, leaving early, temporary gym closure, etc. Please refer to the 2022-2023 SBD All Stars, LLC Program Information for required season payment amounts. All payments will be completed with the card listed on file. A 4% processing fee will be added to the amount due for payment by card.
